#### Council Approves Consulting Service Agreement for Street Improvement Project

Upon recommendation from the Public Works Director, the Torrance City Council unanimously agreed to award a consulting services agreement in the amount of \$290,191 for the Measure R project, which covers Pacific Coast Highway at Vista Montana/ Anza Avenue.

The approved agreement with Onward Engineering of Anaheim will fulfill design services for "potential right-of-way assessments and acquisitions" and project development, which would include obtaining Caltrans permits for the Measure R project F-50.

Four different consulting firms submitted bids for the project, all of which were interviewed on Sept. 30 and Oct. 7 by the selection committee. After evaluating each company's understanding of the project's scope and their ability to perform based on past experience. After close evaluation the committee determined that Onward Engineering was best suited to meet the city's needs. The other firms included Harris & Associates from Irvine, Anderson Penna from Newport Beach and CivilSource from Irvine.

Funding for the project will be 100 percent reimbursed by the Los Angeles County Metropolitan Authority, based on the terms of Measure R Highway Program Funding Agreement. The staff report presented to the council indicates that Measure R, which is the one-half cent sales tax that was approved by Los Angeles County in November of 2008, is designed to address the wide range of transportation needs throughout the county.

One of the components mentioned in the staff report about Measure R is the South Bay Highway Program, which is tailored to provide and estimated \$906 million during a 30-year period (which began in 2008). This money is to fix the much-needed ramp and interchange improvements that will help "improve the operation of access and to the

I-405, I-110, I-105 freeways." Other state routes that are reported to benefit include PCH, Artesia Boulevard, Western Avenue and Hawthorne Boulevard, all in the South Bay. Improvements on these roads include signal synchronization, park-and-ride projects.

On Oct. 14 the council adopted a resolution that would support the South Bay Measure R Highway Program Project List. According to the staff report, that list identifies "currently funded and proposed Torrance projects to be funded" by the highway measure all the way until the 2020-21 fiscal year.

Due to the size of the project and the estimated amount of hours necessary to complete the task at hand, it was determined that design services would be necessary. Engineering staff will be responsible for performing project

and construction management as well as administration.

Onward Engineering was described in the staff report as having "successfully performed similar services for other public agencies," as well as having all references checked and in order.

#### Council Approves Funding for 2015 Rose Float Parade

Based on the recommendation from the Community Services Director, the Torrance City Council approved an agreement between the City and the Torrance Rose Float Association to provide funds for the 2015 TRPF for \$100,000.

This one-time approval of funds in the amount of \$80,000 is available from the **See City Council, page 10**





#### Baked Sweet Potatoes with Cranberry Gorgonzola Gremolata

#### **Ingredients**

#### Serves 6

- 6 medium sweet potatoes
- 1/4 cup melted butter
- 1/2 teaspoon salt
- 1/4 cup pure maple syrup
- 1/4 cup minced fresh parsley
- 1 lemon, zested
- 1 clove garlic, minced finely
- 3 tablespoons minced pecans
- 3 tablespoons finely chopped dried cranberries
- 1 scallion, minced
- 2 ounces Stella gorgonzola, crumbled (If you prefer a milder flavor, use 2 ounces crumbled blue cheese instead of gorgonzola)



#### Preparation

- 1. Preheat oven to 450 F. Place sweet potatoes on cookie sheet and bake for 30 minutes. Flip over and return to oven to bake until tender about 20 minutes. Remove from oven and set aside.
- 2. When cool enough to do so safely, peel sweet potatoes. Place in a medium skillet over low heat with butter, salt and maple syrup for 5 minutes, basting the potatoes with the butter mixture occasionally. Lightly smash the potatoes until there is an even consistency. Hold over low heat.
- 3. To make the gremolata: In a small bowl, toss together parsley, lemon zest, garlic, pecans, cranberries and scallion. Gently fold in the cheese.
- 4. Move sweet potatoes to a serving dish and sprinkle with the gremolata. Serve hot. •

Include the Dodgers, the Angels, the Trojans, the Bruins; you can even throw the Lakers in there. But when Pablo Sandoval caught the final out of the 2014 World Series and raised his arms high into the air with glee, insult was added to injury. Not only did the Dodgers underachieve tremendously this year, but they had to watch their archrivals from up North take home the trophy.

A long-time Dodger fan from Long Beach California, Mer Valdez perhaps said it best: "The first time, I hated it. The second time, I begrudgingly accepted it. This time, I couldn't help but respect it." That's right, for the third time in just five years the San Francisco Giants have won the World Series, sending chills down every Dodger fan's spine. If you're a true baseball fan though, you can't help but appreciate the way the Giants have captured their titles. Sure, maybe they take a year off between each one to rest up, but they are still getting the job done. With a lot of homegrown talent and a few free-agent acquisitions here and there, the Giants and General Manager Brian Sabean have put together a team that can and seemingly does compete for a title every single year. By taking a closer look, the difference between this championship Giants team and the Dodgers become increasingly apparent.

Madison Bumgarner is truly a giant. Not just the one that is painted across all of the San Francisco players jerseys, but a true giant in baseball history. With his recent World Series performance, Bumgarner not only single-handedly delivered a ring to the city of San Francisco, but also became one of the greatest playoff pitchers ever in the process. Bumgarner now has the lowest career ERA in World Series history at 0.25. He won two of the four World Series games for the Giants, saved another, and threw more inning this postseason than any other pitcher in postseason history. In his World Series career, Bumgarner is now 4-0 with 0.53 WHIP and averages eight strikeouts per nine innings.

Now remember those numbers, but make believe I never mentioned the name Madison Bumgarner. If at the beginning of this baseball season, or even at the end of it before the

playoffs started, I were to tell you that one pitcher in the game of baseball would pitch that effectively and attain numbers like those, who would you have guessed it would be? Chances are, not Madison Bumgarner. Clayton Kershaw, maybe? Kershaw's regular season numbers were awfully similar to those of Bumgarner's spectacular postseason numbers. The only difference is Kershaw was watching the World Series from his couch at home. One thing that the Giants have been able to do that the Dodgers haven't is perform at high levels under great amounts of pressure. It was obvious earlier this postseason that once the bright lights hit Kershaw on the mound, he unwound. In this postseason alone, Kershaw finished at 0-2 with a 7.82 ERA. His career postseason numbers are 1-5 with a 5.12 ERA. Clearly, Kershaw has just not been playoff material.

The Dodgers needed an arm to rely on in this year's postseason. Much like Bumgarner, who saved the Giants time and time again, Kershaw was looked at to be the Dodgers' savior. Instead, he was quite the opposite. While homegrown talents like Buster Posey, Brandon Belt, Brandon Crawford and Joe Panik continuously produce in the most pressure-packed situations for the Giants, Yasiel Puig is going on strikeout-sprees, Dee Gordon all but disappears and Adrian Gonzalez suddenly looks old and overmatched. The job that Giants manager Bruce Bochy has done with the Giants should not be understated either. He keeps his team focused, makes all of the right calls and exudes a confidence that keeps his team cool and collected during the most trying times. The Dodgers, however, rely on a bubble machine in the dugout to tell them that they've done a good job.

All in all this year's Major League Baseball postseason has told us two things. One: the San Francisco Giants actually are a really good team, no matter where they finish in the regular season standings and Madison Bumgarner may have dethroned Clayton Kershaw as the greatest pitcher in baseball. Two: if the Dodgers ever want to advance past the National League Championship series, or even get there again, they should take a page out of the Giants playbook. Produce homegrown talent and deliver when the pressure is on and the bright lights are shining. Two things the team has been relatively unsuccessful at doing over the past two and a half decades. The Dodgers (along with the Washington Nationals) are already favored to win the World Series in 2015 (15/2 odds), but unless they fix some major problems both on the field and in the dugout, fans can look forward to seeing the Giants raise yet another banner before the Boys in Blue will ever get the opportunity to. •

It was Halloween night and the West High Warriors certainly gave their home crowd a scare by falling behind early to the Spartans. The first quarter was scoreless all around as most of the players looked as if they would have rather been trick-or-treating rather than playing football. In the second quarter, though, South High decided they would take advantage of West's complacency and get the scoring going. Quarterback Gabe Zuniga provided most of the offense for the Spartans on the night, including 85 yards rushing and a touchdown early on in the second quarter. Later, Zuniga would connect with wide receiver Zack Leets on a 20-yard touchdown pass at time expired in the first half to put South ahead 12-0 at the half.

Ojiyi, who was benched for the first half due to what coach Greg Holt called "disciplinary" reasons, took the field to start the third quarter and was noticed by everyone on the defensive side of the ball. Ojiyi has been the sparkplug for the Warriors all season long and one of the best running backs in the Pioneer League if not the state. If she had read that government had reached two awful milestones, she would have had a seizure. As a corollary, every private sector contract must be bonded and competitively bid with specific quality, schedules and fixed cost. Any contractor who breaches more than one contract would be barred from bidding on future government contracts.

Fifth, remove every department's procurement authority in order to mitigate the influence of lobbyists and other special interests, leaving Purchasing in the hands of professionals.

Sixth, the Office of Management and Budget should have one function only: to monitor all Federal contracts, with full audit authority.

Seventh, all programs should have a defined sunset provision. Any extension should be treated as a new bill, requiring renewed Congressional debate and Presidential approval.

Eighth, the President should have a lineitem veto, but should not have the authority to add funding to any bill.

Mom was also a realist who would not touch the issues of a Balanced Budget Amendment or income tax reform because those are political quagmires that would suck the wind out of all reform proposals, and result in continued political paralysis. Like Mr. Smith who went to Washington, there's an army of smart and principled Moms armed with brooms who have better ideas than politicians. So ink up like a sailor with a heart and Mom tattoo on your shoulder and flash it on Election Day.

#### **Voter ID Laws Do More Harm Than Anything**

The issue of voter ID laws has floated in the news for years now and much of the rhetoric behind justifying such legislation sounds good but in reality is bad. To date I have not seen one clear-cut example of a state that has such rampant voter fraud that voter that a new voter identification law was needed to maintain the integrity of our democratic process, from the voters' side. However, I keep reading articles about Americans in different states that have been denied the right to vote because of new voter ID laws, even though they are law-abiding citizens who have been going to the polls for years.

The most recent article I came across is from a man named Eric Kennie. Kennie is from Austin, Texas and in his 45 years on this earth he ha never lived outside of Austin. Actually, theguardian.com reports that Kennie has never travelled outside of the state, nor has he ever left his native city. Kennie has been an active voter in Texas since he turned 18 but because of the new voter ID law approved by the state's Republican leadership he and an estimated 600,000 legally registered voters will be unable to vote. Under the new law a voter must meet certain photo identification requirements and it has been determined that Kennie fails to do so.

I won't argue against requiring people to provide a legitimate identification card prior to voting. However, if people like Kennie have been voting for years, why are their former forms of identification no longer acceptable? This new law is so absurd that Kennie's voter registration certificate, which was a valid document to vote, is now considered insufficient in Texas to cast a ballot. Furthermore, such laws make it difficult for young people to vote because students usually don't have state issued identification cards. In order to obtain an ID, one needs a birth certificate but to obtain said document, the petitioner needs a state-issued ID. Seems like a convenient way to keep people from voting.

Every article I read, from several sources, indicates the same thing: law-abiding citizens lose their right to vote with these new laws for no legal reason. Affected by such requirements are usually people who are already disenfranchised: the poor and minorities. Our country already has embarrassingly low voter turn out and with voter ID laws, the ability to vote becomes restricted and will only cause less people to try and become part of the voting process.

There is nothing wrong with setting new standards but to deny a people like Kennie the right to vote without any wrong doing on his behalf is wrong. For anyone who argues that people like Kennie should just abide by the new regulations, you're missing the point. People like Kennie have done nothing wrong to lose the right to vote, so they should not have fix or modify their behavior because some state legislators found a way to eliminate potential against votes. If Texas is so worried about the two registered cases of voter fraud in 20 million votes cast during the past two years, there are better solutions than disenfranchising 600,000 people. •



# Penny for Your Thoughts?

The song *Pennies from Heaven* was written in 1936 by Johnny Burke and Arthur Johnston and sung by Bing Crosby and Madge Evans

Ever since pennies have been mixed with copper and nickel, Abraham Lincoln has been on the front. The back has changed over time with special 'mints' and I do know that I am supposed to collect all pennies with 'wheat'

for the first time in the film of the same name back when a penny was really worth something, like one cent. Right now, think of where you might have a penny. Do you keep them in your pocket, a drawer, a purse, a jar, or on a coin card? My 'penny stash' is in a desk drawer neatly taking up space in a compartment clearly designed for rubber bands or paper clips. Last week I decided to collect my pennies and cash them in.

This chore started me thinking about the one-cent copper penny. My husband Dave collected coins and I wish I had paid more attention to all he knew about them. He had cards with 'wheat pennies' with special years and from special mints. I know pennies were first cast well over one hundred years ago in 1793. I remember Dave told me that the first 'copper pennies' were large because they had to have enough copper in them to be worth a cent! It makes me wonder how big a coin would have to be made today to equal one cent. Anyway, in 1957 Congress dictated that the penny be mixed with nickel and the coin was reduced in size. There are many pennies worth a lot of money and collectors keep a 'look out' for old coins. I remember when I was growing up my sister and I would look through pennies hoping to find one with our birth year matching the mint year. We collected pennies, but I can't remember what we used to do with them. We probably used them up in gumball machines! I remember my Uncle Danny collected a huge jar filled

with pennies and other coins telling us he was going to go to Las Vegas. I thought that was amazing at the time. As a child, I envisioned him sitting in front of a penny slot machine with his big jar.

on them. Pennies with two shafts of wheat on either side of the top were minted from 1909 to 1956. The recipe for a penny has also changed significantly over the years and since 1982 pennies are nearly 97.5 per cent zinc. Copper coins contained more than one cent of copper and became too expensive to produce. Most of the new pennies have a shield on the back, but the older ones have the Lincoln Memorial or the wheat pattern (which I am now looking for) on the back. Written across the back of all our pennies lies, "E Pluribus Unum," (out of many, one) which was suggested by committee in 1776. The Latin words stand for the original thirteen independent states of America - unified - into a single country. Our official National Motto, established in 1956 is "In God We Trust" and is written across the top of Abraham Lincoln's side of the penny.

My New World Dictionary of the American Language says; "Numismatics is the study or collection of coins, medals, paper money, etc." There are many who collect coins today and are very knowledgeable about special dates of coins, minting of coins, and the history of coins. Most of my knowledge of our one-cent coin comes from saving them or sifting them out of my purse into a jar, or into my desk drawer.

A month ago, I took a trip to Canada and while I was there, shopping one day, I spotted some very pretty necklaces that had a small enameled disc hanging from the chain. Upon closer look, I saw the enamel painting was of a pretty ladybug and on the other side, to my surprise, was the back of a Canadian 1-cent penny with maple leaves and a date – 2010. The woman selling the necklaces told me that Canada's phasing out of the penny began in 2012 and she decided to use them in her jewelry for customers who wanted to keep a bit of Canada's past as jewelry. Wow, I thought of our pennies and hoped we weren't on the same path.

After reading about collecting and taking advice from those who know, I decided to go through my pennies and pull out any wheat pennies and any pennies minted before 1982. When I found my first 'wheat penny' in my stash that had 'One Cent – United Sates of America' printed on the back with 'E Pluribus Unum' over the top I was so excited! Have I become a numismatist overnight? Maybe. After removing and examining with my loupe all the 'valuable' one cent coins from my large envelope, it left me with dirty fingers and a smaller amount of pennies to cash in than I had when I began. I ended up

keeping a small bowl of pennies I am now officially collecting which have a date earlier than 1982. That pile includes three 'wheat pennies' in addition to one Canadian penny, one two-cent Euro coin, and three pennies that are so green I can't read the date on them. In the end, I have fewer pennies to roll and have decided to gather more before rolling them and taking them to the bank.

Oh, about cashing in my pennies - at the market I found out, after hauling my heavy envelope of pennies to the coin operated machine in the lobby of the grocery store, that I would only receive ninety cents for every dollar I put into the machine. Hum. I left with my pennies and headed to my friendly neighborhood bank only to find out I had to roll my pennies in paper before depositing the coins into my account. Upon further investigation, I found out from a friend that our local credit union would take pennies unrolled. That was good news. Another friend told me his bank would take pennies and count them if customers would simply put them in specially labeled plastic bags. They would count the pennies and then deposit the amount into your account. Not bad.

How many other people collect pennies? Lots, I found. Thomas Kelly told me, "I put [my pennies] in a cookie jar and I roll them up and take 'em to the bank. But I do look through them to look for wheat pennies and I have one – 1948. One penny. So the jar itself will probably hold about fifty dollars in pennies – that's 5,000 pennies – I got one [wheat]." All of a sudden I felt really lucky to have found three wheat pennies in my little stash.

Later that night as I rode with my friend to a Lakers game, I asked her if she collected pennies. She smiled and immediately opened up the center console between the two front seats to reveal a treasure trove of change! After telling her what I'd learned about pennies, she decided not to spend a cent until she checked through all her change.

At this point, clichés come to mind such as, "A penny for your thoughts," "Fresh and new like a shiny new penny," "See a penny, pick it up and all the day you'll have good luck," "Brighter than a lucky penny," etc. Lots of other penny sayings come to mind and I have heard them all my life. Now I look at my change differently. Is there a wheat penny in the handful of change I am given at the store? Now I will check each time I make a transaction. And I will wait a bit before rolling my pennies in paper and taking them to the bank because, 'A penny saved is a..." well, you know the rest. •

the community." She also elaborated on the archival importance of the local paper. "It is a thumbprint of history," she said. Maerker went on to credit her staff for their dedication, adding that it is a huge but worthwhile challenge to find people who are the right fit. "I couldn't do anything I do except for my staff," she said.

Rossberg announced that Torrance Bakery celebrates its 30th anniversary this month and has grown from a "beat-up donut shop" with seven employees to two locations with over 90 employees and 14,000 square feet of combined space. Starting out in the industry at the age of 16, Rossberg said the bakery business is all he ever wanted to do. "There is no Plan B," he said. Asked to provide one piece of advice to build customer loyalty, Rossberg identified customer service as the absolute key.

Lesser, who joined the Redondo Beachbased Body Glove 48 years ago as an accountant and now runs the business, detailed the company's evolution from two lifeguards in the 1950s looking for a way

to solve the nuisance of being cold in the ocean to today's iconic worldwide wetsuit wholesaler. Yet despite Body Glove's international success, Lesser pointed to the fact that it is still run by the same family that started it—and that allows for flexibility that corporate conglomerates don't have. "We can react fast," he said.

Hoping also to find opportunity where there was previously a problem, Khartounian came and smarter than he is, convincing employees to buy into the company's vision, building a strong website, and competing through service rather than price.

Zislis described how at the age of 21, he opened the Manhattan Beach Brewery and turned it into virtually an overnight sensation that allowed him to pay back all his investors in cash within 90 days of opening. A quarter-century later, he employs 14,000

to grips with the reality that watches were no longer deemed valuable as timekeepers due to the advent of cell phones. So he decided to rebrand. "My vision was to create a watch store that doesn't care about telling time, but about accessorizing your wrist," he explained. Khartounian also emphasized the importance of hiring people who are better

people as the owner of Shade Hotel, Rock 'N Fish, Rock & Brews, Brewco, and The Strand House. While other panelists spoke of happy employees who never want to leave, Zislis explained that the very nature of food service typically entails hiring individuals "when they're young and on a career path." Though hard to retain such personnel, he

noted that he was happy "to have their greatness for a few years" before they move onto something else even bigger and better. Despite Zislis' success, he said he won't rest on his laurels--opting to continually make changes to keep the brand fresh. He also puts a premium on customer service, telling as an example the story of a disgruntled diner who called him to complain about not getting a baked potato with her meal. This prompted Zislis to drive to the woman's house to deliver the spud himself-and that gesture won her over for good. Finally, Zislis and the other panelists stressed the importance of community involvement, with the restaurateur adding that he only likes to advertise in "local papers" such as the Herald Publications' weeklies.

The panelists also shared another element that allows them to thrive in ever-changing economic times: a tireless work ethic. "If you're a small business owner, you work all the time," said Maerker. "I keep dreaming of vacations... but I do love it [running the papers] or I wouldn't still be doing it..." •


