Torrance City Council Approves R Panel Installation at Wilson Park

On Tuesday night, the Torrance City Council amended the current services agreement with OCC Builders, Inc. for an additional \$30,472, raising the contract to no more than \$153,322 for the installation of R Panels at Wilson Park. The installation will take place between November 14, 2017 and September 11, 2018, with money being made available in the approved capital project budget.

"The installation of R Panels at Wilson Park project replaces 16 deteriorated wood trusses that have been recently removed around the hockey rink at Wilson Park as well as the existing metal panels and canvas tarps that have also deteriorated through the years," states the staff report signed by Business Manager Nina Schroeder.

With the new R Panels, hockey players will be shielded from the sun as they play. The installation will also enhance the Wilson Park facility's appearance and endurance. Each panel is made of steel and covered with coated layers of galvalume (an alloy with both zinc and aluminum used to coat metal) and paint, which has a 25-year warranty. The original idea was for a combined use of seven beams along with vertical steel tubes that would provide support to the panels—but after a discussion with structural engineers about similar projects, it was determined that such support was not necessary at the time.

However, during a job walk on July 6, 2017 and with discussion with the potential

contractors, "it was determined by General Services that it would be prudent to call out for a review of the structural support of the R Panels by a licensed structural engineer," states the staff report. "The design for the supports would also be reviewed by the City's Building and Safety for approval of structural design."

Once the project was awarded, the structural engineer identified a more structurally safe design for the installation of R Panels. The

new design would eliminate the use of pipe support to existing I beams in each 20-foot span section around the hockey rink and instead install nine additional I beams.

Also on Tuesday, the Council approved a recommendation by Public Works Robert J. Beste to authorize City Manager LeRoy Jackson to negotiate terms and sign the Proposition 1 Grant Agreement. This approval designates

Another Thankful Thanksgiving

As Thanksgiving rolls around again next week, it is time for remembering everything for which we are thankful. Thanksgiving has been celebrated in our country for over a century and a half. President Abraham Lincoln signed Proclamation 118-Thanksgiving Day on October 20, 1864. Within that proclamation it states, "Now, therefore, I, Abraham Lincoln, President of the United States, do hereby appoint and set apart the last Thursday in November next as a day which I desire to be observed by all my fellow citizens, wherever they may be, as a day of thanksgiving and praise to Almighty God, the beneficent Creator and Ruler of the Universe. And I do

further recommend to my fellow citizens aforesaid that on that occasion they do reverently humble themselves in the dust and from thence offer up penitent and fervent prayers and supplications to the Great Disposer of Events for a return of inestimable blessings of peace, union and harmony throughout the land which has pleased Him to assign as a dwelling place for ourselves and for our posterity throughout all generations..." Although Thanksgiving was celebrated on the last Thursday in November, it was changed by an act of Congress in 1941 to the fourth Thursday of November, where it remains today. This year, Thanksgiving falls on November 23.

Nobody Really Knows When Tax-Filing Season Will Start, IRS Included

Nearly every taxpayer knows that April 15 is the deadline for filing federal and state tax returns, or requesting an extension. But what about the first day to file those returns and, hopefully, wait for a refund?

Even the Internal Revenue Service doesn’t know when it will begin accepting 2017 federal returns, according to a bulletin released last week. The bureau said the start date depends on what Congress decides about “extender” tax breaks that expired at the end of last year.

Opening day for tax-filing season typically falls on a Monday after Martin Luther King Day, according to spokeswoman Cindy Hockenberry with the National Association of Tax Preparers. Not knowing the first day of e-filing next January isn’t a problem yet for the group’s members, she said. “It would be if we get to January 5 without a start date for e-filers,” Hockenberry noted.

This year, the IRS didn’t start accepting electronically filed federal tax returns until January 23. In past years, the date has been set as early as January 16, giving tax preparers an extra week in what is a long and grueling tax season for them each year.

No matter which January date the IRS selects, federal refunds won’t be issued until

mid-February at the earliest next year, said Hockenberry with the 23,000-member tax preparers association.

The IRS needs Congress to decide whether to extend four tax breaks for individuals and another dozen for businesses that expired on December 31, 2016. Typically, Congress waits until late in the year to approve a package of temporary tax extensions, and this year is no exception with the House and Senate working feverishly on a tax plan that President Trump wants on his desk before Christmas.

The four individual tax breaks waiting for a congressional thumbs up are:

Mortgage insurance premium: This affects homebuyers who can’t make a standard 20 percent down payment on a home or condo. The deduction for the amount of the insurance premium had been on the books since 2017. Known as PMI, these policies protect lenders in case buyers default on their mortgages. The tax savings can be in the hundreds of dollars per year, tax experts say.

Debt forgiveness on a home loan: The housing crisis is over, and so is this tax break as of December 31. The Mortgage Forgiveness Debt Relief Act of 2007 helped underwater homeowners who lost their homes to a short sale or foreclosure. The act, which allows for the exclusion of forgiven mortgage debt from income, was extended several times in the past.

Medical expenses for seniors: People 65 and older and their spouses could deduct medical expenses that exceeded 7.5 percent of their adjusted gross incomes. Without the tax extension, the threshold for deducting medical bills would rise to 10 percent and leave seniors with higher tax bills.

Tuition and college fees: This tax break to make a college education slightly more affordable for students and their families disappeared last year. The tuition and fees deduction reduced a person or family’s taxable income by \$4,000--which they could claim even if they didn’t itemize their deductions.


Energy-saving home improvements: As of January 1, homeowners no longer could claim a 10 percent tax credit for energy-efficient improvements. The credit had a lifetime limit of \$500, so for some homeowners an extension won’t lighten their tax liability come January when e-filers can submit their 2016 federal and state tax returns.

The average federal refund last year in California was \$2,810, according to the IRS. As for the exact date when a tax preparer, enrolled agent or certified public accountant can hit the send button, the IRS said it expects to make an announcement later in the year. Until then, the IRS advises the public and tax professionals to ignore anyone claiming January 22 or after MLK Day is the official date. “Any speculation about refund dates in 2018 is premature,” the IRS said in a November 3 bulletin. Once Congress recesses for the holidays, the IRS will make updates to its system that would include any tax break extensions lawmakers approve.

Congressionally-approved tax breaks for individuals and businesses renew on a two- or five-year basis, though federal lawmakers recently made a number of deductions permanent for teachers who purchase school supplies, people 70 1/2 and older to withdraw \$100,000 from their individual retirement accounts without ballooning their tax bills, and for companies to claim a research credit.

For the second year in a row, state and federal returns won’t be due on April 15. Because the 15th falls on a Sunday next year, filers will have an extra day to complete and mail or e-file returns to the IRS and California Franchise Tax Board in Sacramento. Nine in 10 returns last year were electronically filed.

This year, Congress is the one procrastinating on income taxes. By doing so, it has put added pressure on the preparers, tax law trainers and business software developers to be ready for next season’s opening day. •



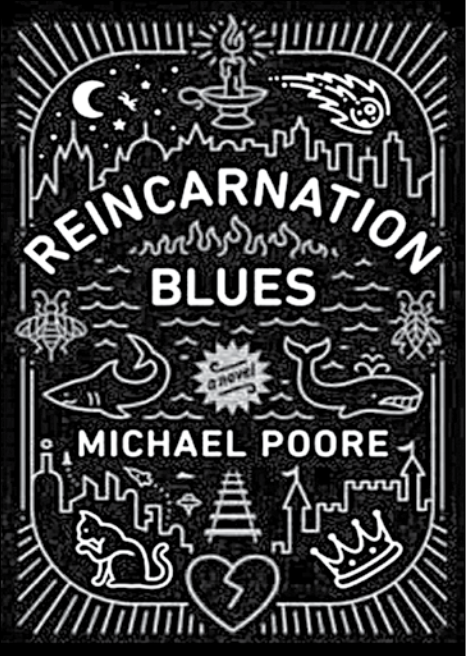


Check It Out

Thoughtful *Reincarnation Blues* Explores Time Travel What Ifs

I love time travel books, especially ones that explore the infinite "what if" scenarios that could possibly exist if we'd chosen a different path. Amongst my favorites are Audrey Niffenegger's *The Time Traveler's Wife*, Andrew Sean Greer's *The Impossible Lives of Greta Wells* and most recently, Michael Poore's *Reincarnation Blues*. This darkly funny, inventive tale follows Milo, who has lived nearly 10,000 lives trying to achieve

the ultimate goal of reaching "perfection."
We see glimpses of some of Milo's lives past, present and future, as well as his experiences in the afterlife between being reincarnated--including his relationship with a manifestation of Death, who prefers to be called Suzie. Part dystopian science fiction, part historical fantasy, Poore's book also delves into the philosophical, examining questions of purpose and fate. The book also explores social justice themes such as the powerful exploiting the weak, and how best for humanity to combat and overcome oppression.

Warriors, Saxons One and Done

Kings Look to Recapture Throne

It was back in the first week of October that the West High Warriors received their first real wakeup call of the regular season. That week, West and their head coach Greg Holt went up against their inner-city and divisional rivals from North High and were shut out in what wound up being a 3-0 loss. The loss was the fourth in a row for the Warriors, but the team rallied and went on to win their final four games of the season to complete a miraculous turnaround and make it into this year's CIF Southern Section Division 6 playoffs. Unfortunately for West, the storybook season would end there as a more prepared and aggressive St. Paul Swordsmen team put up huge first and third quarters on the way to a 48-14 defeat of the Warriors in the first round of play.

"We knew it was going to be a tough game tonight because they are a very physical team," Holt said of the matchup against the Swordsmen. "They ran the ball well and we didn't wrap up and tackle them." St. Paul's dominance on the offensive end indeed began with the running game. Swordsmen quarterback Chris Garcia got things started off on the ground early in the game as he took the ball in from one yard out to put the Warriors in an early 6-0 hole. Not long after, the Swordsmen attacked again--this time putting West on its heels with a Que Allen touchdown scored from four yards out. At the end of the first quarter, the Warriors found themselves looking at a 13-0 deficit.

West was finally able to get on the board in the second quarter when the offense finally began to get going behind quarterback Brandon Poffenbarger and running back Gus Eckert. Eckert charged the team down the field before Poffenbarger ran the ball into the end zone for a touchdown to cut St. Paul's lead to just six at 13-7. West's score only seemed to ignite an already rampant Swordsmen offense. From that point on, St. Paul rallied off 35 straight points. The Warriors scored again with under one minute to play in the fourth quarter on a Poffenbarger touchdown pass, but at that time they were already too far out of contention. A second half dominated by the Swordsmen and their running game saw West take a first round 34-point loss to quickly exit this year's playoff race.

"We just got outmatched physically," Eckert said of his team's performance in the game. "They were very large and just moved us back all night. We just didn't have an answer for them defensively." Eckert's words ring true when looking at the game's box score. St. Paul combined for 402 yards and five touchdowns on the ground alone. Despite Poffenbarger's two touchdowns and 142 yards through the air, West was still completely outmatched in the game. Even still, the Warriors remained grateful for such a thrilling season of football. "I'm proud of how hard my team fought right up until the end," Holt said. Eckert echoed those sentiments. "I'm proud of our team and how we fought back this year," he said. "We had a great season."

West finished the regular season with a 5-6 overall record (4-1 in Pioneer League play) and a second place finish in its division. The good news for the Warriors and Holt is that the team should certainly be back in

contention next season. With the return of Poffenbarger and other key players like the quarterback's favorite wide receiver, Dutch Silverlake, West should be primed for a breakout season and a playoff run in 2018.

North High

The North High Saxons were this year's standout team from the Pioneer League, finishing in first place with the best overall record in the division. Unfortunately, not even a great record of 8-3 could get head coach Todd Croce and company past the first round of this year's CIF Southern Section Division 7 playoffs and their opponent, the Fullerton Indians. A high-scoring affair eventually saw the Indians come out on top, as North High surrendered an early lead in what eventually became a 43-30 loss last Friday night at home.

The Saxons came out raring and ready to go in their first round matchup against Fullerton and put a touchdown on the scoreboard nearly as soon as they received the ball on the opening kickoff of the game. A blocked point-after attempt left the door open for the Indians to take the lead with just one score--and that's precisely what they did. A 15-yard rushing touchdown by Fullerton got the scoring started for the Indians in the second quarter of play. North responded with a field goal, and a back-and-forth first half eventually ended with the Saxons surrendering their first quarter lead as they went into the break trailing by a score of 14-9.

North once again began a quarter with energy. The team recovered an onside kick to start the second half and then put the ball in running back Saeed Galloway's hands and watched him go to work. It wasn't long before that decision would see the Saxons wind up with more points on the board, as the team regained a 17-14 lead after a successful two-point conversion. That's precisely when things took a turn for the worse for North High. The team's three point lead was extremely short-lived as the Indians immediately responded with not just another seven points on the scoreboard, but a total of 21 unanswered points to ultimately put the game out of reach.

Saxons starting quarterback Sean Sigala led the team on a drive down the field in the fourth quarter that eventually resulted in a passing touchdown for the junior to make the score 35-24 with just over three minutes to play. He would connect again in the final minutes to bring his team's final score to a total of 30, but Fullerton's offensive explosion eventually proved to be too much for North High to handle. On a night where the Saxons simply couldn't stop the ball, Croce and his team saw their playoff run ended with a 43-30 loss at home.

The Saxons finish the 2017 season with an 8-3 record and an undefeated mark of 5-0 in league play on the season. North will lose both Galloway and Sigala to college next season, but will retain the services of backup quarterback Mehki Jordan, who received playing time throughout this year's regular season. In all, North will lose 19 seniors to graduation in the offseason, making Croce's job at capturing a second consecutive Pioneer League championship even that much harder to do.

A disappointing 2016-17 season seems to be a thing of the past for this year's Los Angeles Kings. It's quite amazing the effect a fresh face can make on a team that has championship talent. New head coach John Stevens has a roster that is essentially full of the same players as last season. That same roster of players, though, is playing at a much higher level than they were at this same time one year ago. The Kings newly improved, up-tempo style of play has Anze Kopitar, Dustin Brown and the rest of Los Angeles skating alongside the best teams in the league to open up the new NHL season. As a team that is looking quite dominant in this year's Pacific Division, Stevens and the Kings may have found what it takes to recapture some of the magic from their recent Stanley Cup-winning teams.

Led by a resurgent captain in Kopitar and a goalie who looks to have found himself once again in Jonathan Quick, the Los Angeles Kings have become a threat to just about every opponent that they face, specifically in the Pacific Division. While Quick is standing on his head, Kopitar is quickly approaching his season total in goals from last year (12) less than two months into the beginning of play. Even still, around the league you'll find many NHL "truthers" who are hesitant to put their belief behind this new-look Los Angeles team. Early success both at home and on the road, however, should tell all who watch the Kings that they are indeed for real.

One of the main reasons for the Kings' early success is the play of the aforementioned Quick. Then there's Kopitar. The captain of the team as of last weekend led in every major statistical category on offense, including goals, assists and points. A loss last week against the NHL's best team, the Tampa Bay Lightning, provided a slight setback for the Kings who had been on a roll in winning nine of their previous 12 games. "I do think they're [Tampa Bay] the best team in the league," Stevens said after

his team's loss, adding perspective. "They're a different animal and we have some work to do." Even still, it has become clear that Los Angeles has shed its low-scoring style play in favor of a much more up-tempo, high-flying style under Stevens that should keep the Kings formidable going forward.

It isn't just the big names getting the job done for the Kings. While the team remains a veteran group, it has gotten nice contributions from the younger players on the roster to begin the season. Adrian Kempe is one player who has been at the forefront of the production that the team has received from those younger players. Kempe has already come through with a few key assists that have not only led to points for the youngster, but have also added to wins for Los Angeles. Rookie Michael Amadio has also made a name for himself in the early going, while contributions from Tyler Toffoli and Tanner Pearson--who are both only 25 years of age--have added to an aggressive Kings attack that is well-balanced in age and in skill level.

"I think the fact we're getting production outside of just top guys has been helpful," Stevens said of his team. "We've had different parts in our lineup that's contributed. If I had to put a big difference on it, I think our top guys have been on this year and it's really helped." There's no doubting that Quick, Kopitar and Brown (who is also closing in on his goal total from last year) playing at their peak levels is good for everyone involved. When the Kings can get contributions from every player on the roster, though, they immediately become a threat to every opponent in the league.

The hockey year is still young for the Los Angeles Kings and there is plenty of time left for the team to go through the many ups and downs that come with a long and trying NHL regular season. After winning just one playoff game over the course of the last three seasons, though, one would think that this year's team most definitely has something to prove. A new front office, a fresh face behind the bench and a different style of play have already worked wonders for Los Angeles in the early going. Now, if Quick, Kopitar and the rest of the Kings can simply sustain their elite style of play, it wouldn't be an exaggeration to say they can compete with any team in the league to once again recapture this year's Stanley Cup.

Jackson as the “director” of the Torrance Airport Storm Water Infiltration Project, which has been approved for a \$450,000 grant.

The City of Torrance is part of the Machado Lake Watershed and is obligated to meet the Machado Lake Nutrient Total Maximum Loads (TMDL), as well as the Machado Lake Toxics (TMDL) established by the Los Angeles Regional Water Quality Control Board. In order to meet these obligations, the City contracted with Carollo Engineers in 2012 to work on the Machado Lake Enhancement Watershed Management Plan (EWMP). Through the Machado Lake EWMP, three projects will be capable of diverting storm water for groundwater recharge: Water Basin Project, I-173; Torrance Baseball Field Basin (currently unfunded); and the Airport Storm Water Infiltration Project, I-174.

“The purpose of the Torrance Airport Storm Water Infiltration Project is to divert storm water from the Los Angeles County Flood Control District’s double 8’ – 9”W x 10’-1”H Reinforced Concrete Box culvert that originates in the Palos Verdes Peninsula and

travels across the Torrance Airport,” states the staff report signed by Beste and Jackson. “The storm water would be pre-treated and store underground for groundwater recharge.”

On July 13, 2016 the State Water Resource Control Board notified the City that the latter had been selected for a Storm Water Grant Program Proposition 1 Planning Grant, which would help fund the preliminary and final design of the Torrance Airport Storm Water Infiltration Project. The \$450,000 grant will cover half of the estimated cost of the project, but allows the City to get work started. On Aug. 8, 2017 the Council approved the Airport Storm Water Infiltration Project and approved matching funds worth \$125,000.

“The State’s Grant Manager has requested that the City of Torrance approve a new resolution that keeps the responsibilities to negotiate terms and sign the Proposition 1 Grant Agreement and the Project Director responsibilities with one person,” states the staff report. Staff will use the final design plans to seek additional grant funding. •

Roasted Sweet Potatoes with Onions, Grapes and Feta

Recipe provided by BPT

Ingredients

- 4 medium sweet potatoes
 - 1 tablespoon extra-virgin olive oil
 - 1 jumbo yellow onion, halved and thinly sliced
 - 1/2 tablespoon turmeric
 - 1 tablespoon white wine vinegar
 - 1/2 teaspoon kosher salt
 - 1/2 teaspoon freshly ground pepper
- 1 cup halved red or black California grapes
 - 2 tablespoons chopped toasted, salted pepitas
 - 2 tablespoons chopped cilantro
 - 2 tablespoons chopped mint
 - 1/4 cup crumbled feta



Preparation

Serves 4

1. Heat the oven to 400 F. Pierce the potatoes all over with a fork, place on a foil-lined sheet pan and bake for 1 hour or until potatoes are tender. Alternatively, wrap the potatoes in a damp paper towel and microwave 8-10 minutes or until soft.

2. While the potatoes are roasting, heat the oil in a large skillet over medium-high heat. Add the onion and cook until softened and lightly browned, about 8 minutes. Stir in the turmeric, vinegar and salt and pepper and cook 2 minutes longer. Stir in the grapes and turn off the heat.

3. When potatoes are done, cut off the top quarter of each potato, fluff the insides with a fork. Top with the onion mixture, pepitas, cilantro and mint and sprinkle with feta. Serve. •

Ryan-The Shape of Water

Imagine *Beauty and the Beast* set in 1960s Cold War America and the beast is an amphibian-man wanted for use as a weapon by both U.S. and Russian intelligence. This is essentially Guillermo Del Toro’s latest film, *The Shape of Water*. You have the outline, however. The special ingredient to this magical film is that it’s an unapologetic fantasy romance, lush and loving in a way that Del Toro hasn’t done before. Sally Hawkins stars as the mute janitor Elisa who falls in love with “the asset,” the otherworldly Amphibian Man (Doug Jones). She plots to help him escape past the head of security, agent Richard Strickland (Michael Shannon), so that the two kindred souls can be together in love. With its gorgeous cinematography and wholly imaginative story, *The Shape of Water* will certainly be a film to see when it hits theaters this December.

Nelson-Sweet Country

In this Australian western from director Warwick Thornton, white frontiersmen and the indigenous Aboriginal people of the Out-back grapple with the tensions felt between both cultures. Familiar faces (including Sam Neill, *Jurassic Park*) are cast against a mostly unknown ensemble of Australian actors to tell a gripping story of the aftermath of a murder. Shot on film in the gorgeous and sometimes bleak Aussie landscape, *Sweet Country* employs a unique story structure (being made from an international perspective) that arrives as a fresh take on America’s most archetypal film genre. In the film’s preceding Q&A, Thornton revealed that the script was written by his longtime sound editor David Tranter--an Aboriginal man himself-who adapted the story from his grandfather (and on whom the character of 11-year-old Philomac was based).

Jasper-Sammy Davis, Jr.: I’ve Gotta Be Me

There’s a line in *Sammy Davis, Jr.: I’ve Gotta Be Me* that hails Davis as “showbiz.” The true definition of an entertainer. If Sam Pollard’s documentary proves nothing else, it’s that. Playing it fairly straight in telling Davis’ story, this is a reverent documentary, but honest. Pollard presents a complicated man and a pioneering American figure who can be found both singing on the stage and marching in the streets. A figure as multi-dimensional as Davis is deserving of a film as comprehensive as *I’ve Gotta Be Me* and, much like his own impeccable rhythm, not a beat is missed. •
