### **City to Prefund Other Post-Employment Benefits Via CalPERS/CERBT**

A recommendation by the Finance Director Eric Tsao to approve the Agreement and Election of the City of Torrance to prefund Other Post-Employment Benefits through the California Public Employees' Retirement System/ California Employers' Retirement Benefit Trust was given the go-ahead by the city council.

Funding for the prefund will be made available via the city's operating budget in an amount no less than \$5,000 and not to exceed \$10,000. In addition, the mayor and council voted to approve a delegation of authority to request disbursements, as well as giving the city manager [or his designee] the authority to take all necessary actions to participate in the CERBT program.

"Staff is recommending to establish an 'OPEB Trust' under the guidelines of Governmental Accounting Standards, which would allow the City to have OPEB assets invested in higher yielding investments," states the staff report presented and signed by Tsao. "Currently, these assets are part of the City's Investment Pool which which is restricted to fixed income investments with a duration of five years or less." Medial benefits are provided to retired employees by the city. At the moment, any general employees that retire with the city and maintain health insurance via CalPERS are qualified to obtain \$122 per month in health insurance benefits. Retired police officers that have served a minimum of 20 years and have reached the age of 50, they qualify to receive \$332.62 a month until reaching the age of 65: at that age the monthly amount is reduced to \$134 a month. Fire retirees are eligible for \$146.50. "These benefits are referred to as Other Post-Employment Benefits (OPEB)," states the staff report. "The City's OPEB benefits are paid at the time the expense is due (cash basis). This is unlike the other City pension

expenses in where the expense is realized when earned (accrual basis)."

Since the payment of OPEB expenses are due without being earned, they leave the city with unfunded liabilities growing over time. In a proactive move, the city began funding OPEB expenses several years ago through an actuarial basis. Since that time the city has accumulated \$5.625 million in assets.

"Currently, these assets are part of the City's Investment Pool which is restricted to fixed income investments with a duration of five years or less. The City's Investment Pool's main purpose is to meet the cash flow needs of the City."

OPEB trust investments are considered to have more latitude in investment choices, putting them on pace to earn six to seven percent on average over time. Bartel & Associates was contracted by staff for assistance in finding an OPEB Trust provider for the city. B&A, which provides actuarial services to more than 250 California public agencies, sent our a Request for Proposals to known Trust providers and received five responses. Other respondents to the RFPs included: Keenan & Associates, Public Agency Retirement System [PARS], Public Financial Management [PFM] and Robinson Capital Management [RCM].

"Each of the responding companies are well known, have good reputations, are financially sound, and understand OPEB and OPEB trust services," states the staff report.

CalPERS/CERBT was selected based on a rating criteria created by the City and B&A, which factors in investment options, investment return, fee structure and cost, public See City Council, page 9

### **ECCC District Board Appoints** New Superintendent/President

The El Camino Community College District Board of Trustees voted unanimously Monday to appoint Dr. Dena Maloney as the Superintendent/President, effective February 1, 2016.

Maloney, who will become the sixth Superintendent/President in the El Camino Community College District's 68-year history, has ties to the South Bay. She was born at Centinela Hospital in Inglewood, lived in Hawthorne spent her summers with her grandparents in Inglewood.

Maloney currently serves as Superintendent/President of the West Kern Community College District/Taft College. She began her career in higher education at College of the Canyons in Santa Clarita, where she served as director of the Employee Training Institute and director the Center for Applied Competitive Technologies. She then became dean of economic development for the Santa Clarita Community College District. In 2007, Maloney was named founding dean of the Canyon Country Campus, a new educational center within the Santa Clarita Community College District. ### LAX To Be Busiest U.S. Airport This Thanksgiving

Airport officials to announce that a record 2.1 million travelers will pass through Los Angeles International Airport (LAX) this Thanksgiving. Travelers can check our LAXisHappening.com website for real-time traffic and flight conditions before coming to the airport.

Travelers are strongly encouraged to take public transportation to and from LAX, including the inexpensive LAX FlyAway bus and Metro Rail Green Line, as well as taxis, long-distance buses, and other shared-ride services. Airport officials also recommend motorists picking up arriving passengers to use the LAX Cellphone Waiting Lot at 96<sup>th</sup> Street and Vicksburg, where they can wait up to two hours for free. Motorists can avoid driving in the terminal area altogether by asking arriving passengers to take the free LAX Shuttle C bus to Parking Lot C, adjacent to the LAX Cellphone Waiting Lot. Passengers planning to depart LAX during daily peak travel periods from 6 a.m. to 9 a.m.; from 11 a.m. to 2 p.m.; and from 7 p.m. to 11 p.m. arrive in their airline's ticketing lobbies two hours before domestic flights and three hours before international flights.•

- No longer responds to sounds or sudden loud noises





The holiday season is typically a time for families to come together, to enjoy each other's company and reminisce about the year's highs and hopes for the future; a time when the mere act of being in each other's presence signifies the love shared by all. As a dense, dialogue driven family drama of a film, whose DNA comes from the savvy stage play, it hangs its hat on its veteran actors and performances. From Streep and Roberts, their impassioned acting packages the whole film, and sets the series of events on a rightful due course. Roberts returns to the screen at the top of her game.

### **Fall From Grace**

The Land Down Under has certainly seen some crazy things in its time, but perhaps none crazier than what the world saw happen in Australia on Saturday night, November the 14th. Ronda Rousey, the former Olympic Judo fighter who was previously undefeated in 12 professional fights, winning most of them faster than you could even blink, went down in UFC 193 to her opponent, 34-year-old

foot and was out-cold on the mat. Despite all of Rousey's trash talking before the fight, Holm kept it classy afterwards telling Rousey in the middle of the ring once she was able to get up, "I really admire you for being such a great, dominant champion. None of us would be here without you, so I appreciate you."

We've all appreciated Rousey as well. Seeing her dominate her previous opponents was a thing of beauty and witnessing her

Holly Holm. The 28-year-old Rousey didn't just lose, she was utterly and completely outmatched by the former 18-time World Boxing champion. "Rowdy" Ronda Rousey was left even rowdier by Holm, who delivered one of the most brutal kicks to the head in UFC history to the former champ, knocking her out less than a minute into the second round. There's no telling whether Rousey's first loss of her career will ultimately be good or bad for her brand, but one thing is certainly for sure; the dominant performance put on by Holm has exposed Rousey as a human just like every other fighter in the UFC.

For a while, Ronda Rousey was perceived as unbeatable and better than every other fighter in her sport. There was even talk that she should fight undefeated boxer, Floyd Mayweather. Thank goodness that she didn't. If there was anything that we all learned from the fight that took place almost three weeks ago now, it's that Rousey is, indeed, vulnerable. She has yet to make an appearance in public since her crushing loss, but Rousey has since issued a statement. "I just wanted to thank everyone for the love and support," it read. "I appreciate the concerns about my health, but I'm fine. As I had mentioned before, I'm going to take a little bit of time, but I'll be back.'

The concerns for Rousey's health were not unwarranted. She was, after all, taken to a local hospital following the match. It was announced that the transportation was something that was done by the UFC after every knockout in the sport to assure the safety of the fighter. Knockouts like the one that Rousey suffered put fighters at major risk for brain damage, but apparently, and fortunately, she was released with a clean bill of health and plans to fight again. That plan, however, will have to wait. Rousey was given a minimum 60-day suspension by the UFC and was ordered to go 45 days with no contact training. She could be suspended from the sport that she loves for as long as skills - especially her patented arm bar - was something that hasn't been seen before. So was this loss good or bad for the previous champion? Obviously it's always bad to lose. Her perfect 12-0 record now has a blemish and the money comes with winning. She was starring in movies and appearing on late night television, all because she was a winner. Her star had never burned brighter. Rousey was untouchable. Almost this generations greatest athlete ever. Maybe - just maybe - losing saved Rousey's career though.

Ronda Rousey didn't know what it was like to lose. She was undefeated and almost getting bored with the sport. Gravitating towards show business, Rousey was gaining other priorities, like starring in the remake of the Patrick Swayze film, Road House. Rousey was bored with the sport of UFC that she had dominated so easily. Her newly acquired arrogance and sense of bravado that she hadn't previously demonstrated may have been telling enough. Rousey needed to lose to regain her passion for the sport. To lose in front of everyone - on a stage that is brighter than any other in the world - reawakens a passion for the sport unlike any other. Kobe did it. LeBron did it. Tom Brady has done. All of the greatest athletes in the world are fueled by losing on the biggest stage possible. Rousey just took that loss. Now she will come back even stronger and more motivated, with a new, more substantial interest in her sport.

For Ronda Rousey, it's not the end of the world. There is obviously already talk of a rematch with Holm. UFC president, Dana White, confirmed that the two would be headed for another fight almost immediately after Rousey is cleared for contact again. All that the loss means for Rousey is that she is not perfect. No one is. The loss is just another bump in her road and serves as impetus for her to get better as a fighter. Rousey shouldn't have tried to spar with Holm. She should have taken her to the ground and tried to get her in the arm bar that has worked so flawlessly for her in the past. Instead, Rousey was out to prove that she was a better boxer than the 18-time World champ. Now, Rousey is smarter. She has been brought back down to earth and will come back stronger and better off for it. Rousey is human. With that, she fails. So do we all, but just like any human who has failed before, she will be back. There is success in her future. It just needed failure to make it more tangible and appreciated. 



around children each day brought so much happiness into my life," said Donna.

Three years later Donna was recruited to be Development Director, Student Activities Director, and Pep Squad Moderator at Notre Dame. "This position was a little bit of everything I had done throughout my career, from working with students in ASB to fundraising. Pep squad moderator was a bit of a stretch," chuckled Donna.

But after seven years, the Duperrons moved from Corona to Torrance when Gary was recruited to teach and coach at North High. As soon as their three children became acclimated, Donna began volunteering, becoming active in community affairs.

Donna is a past President of the Torrance Kiwanis Club, an office she held on two occasions. She is a certified member of Torrance CERT (Community Emergency Response Team). She is a member of the Pediatric Therapy Network Community Advisory Board. She serves as a Block Captain. And was a member of the Torrance Centennial Committee.

In 1998, Donna looked for a job locally and, using her background as Activities and Development Directors, applied for a position as an Events Planner for the Torrance Area Chamber of Commerce.


