LA Lakers Provide Dream Job for Torrance's Michelle McIntyre

Torrance resident Michelle McIntyre has what many would call a dream job. Born at Centinela Hospital, she was raised in Torrance, attended Fern Elementary, Madrona Middle School, and then attended Torrance High School. "My first job, I worked at J.C. Penny in the Del Amo Mall when I was 16," said Michelle. "I got a work permit from Torrance High and I worked in retail at J.C. Penney. I did a few other things... I was a receptionist for a chiropractor when I was in college, and then I worked at Hollywood Video. Remember that on Hawthorne and Torrance Boulevard?" She then applied for and got a filing job with the Los Angeles Lakers organization when she was 19 years old. She worked three days a week, helping out around the office filing, doing anything asked of her and learning a lot about the organization. Once she graduated from college, Michelle applied for the customer service job and was hired. She had learned a lot about the organization. "I became the Senior Rep a few years after that and then last December, I became the Manager of Service and Retention for the Los Angeles Lakers," added Michelle. Michelle continued, "There are only 30 NBA [National Basketball Association] teams and only so many jobs within those teams. It is a very small group of people who get to do what I do." She manages the service staff and the account reps for all the Lakers season ticket accounts. She has been doing

this job for so long, she also mentors the new reps. Michele told me, "I make sure that we are giving the best service that we can to our Laker season ticket members. I am also in charge of coming up with ideas of how we can give back to our season ticket members and make sure that they want to stay with us and renew year after year. This is a new position within our organization." I find this particular job incredible. I mean, they have someone working this hard on retaining season ticket subscribers when there are about 4,000 people on the waiting list? That is remarkable. In speaking with Michelle, I was impressed with her commitment to the Laker organization.

Then I asked Michelle if her family was a basketball family when she was growing up she said yes. They had always followed the Los Angeles Lakers and her grandfather had played basketball in the Navy in WWII. At this point I asked Michelle if she knew if her grandfather ever played against the

Insurance Changes Bringing Much Needed Relief to Medical Practices

A new law will make it possible for small companies to afford workplace accident insurance next year by loosening the rules on privately-owned businesses, says the South Bay lawmaker who sponsored the bill.

Senator Steven Bradford, D-Gardena, said that more owners and board members of California corporations can opt out their company workers' comp policies under his bill. Part-owners and directors will be allowed to waive coverage as long as they have other health insurance to cover them in case of accident or illness.

The Legislature's efforts to reduce cheating by employers have made it harder

on small business owners, according to Bradford who represents the 35th District. The California Department of Insurance says that workers' comp premium fraud occurs when a company underreports the true number of employees on its payroll. The new law doesn't take effect until July 1, giving small businesses time to decide who'll claim the exemption. The California Medical Association predicted that owners of medical practices will sign up immediately for the waivers.

"All owners of medical corporations will be able to exempt themselves from workers' compensation coverage, regardless of percentage ownership, as long as they **See Insurance Changes, page 9**



Film Review Rapturous *Call Me By Your Name* Is a Sunshine-Soaked Love Story

"Is it better to speak, or to die?" These are the words Mrs. Pearlman reads aloud to her son, Elio (Timothée Chalamet) and her husband from the love story about a prince who doesn't know whether or not to express his love to the princess--the love of his life--or not. Lounging about in the living room of their 17th Century vacation villa in Northern Italy, the Pearlman family takes in the endless summer afternoon of 1983. The prince's quandary is the same one felt by young Elio when exchange student Oliver (Armie Hammer) comes to stay with the family in Luca Guadagnino's latest film, Call Me By Your Name -- a beautiful film of discovery and pure love, and one of the best films of the year.

The summer will be a transformational one for the intelligent, but still boyish 17-year-old Elio, who spends his afternoons studying classical piano sheet music and reading novels. His academic parents may have been able to culture him on the finer things in life regarding art and history. However, Elio finds himself inexperienced when it comes to understanding his feelings and own sexuality. It is only when his father's 24-year-old American intern, Oliver, arrives at their family's home to study for the summer that Elio is awakened to the feelings of pure love and desire for the very first time.

Call Me By Your Name (much like our previously reviewed film, *Thelma*) explores the theme of finding one's voice and navigating through the messiness of being in love against the backdrop of coming to understand one's sexual desires. It plays like a beautifully orchestrated dance. The patient, measured pace allows the audience to experience all

of the visceral and sensual moments the film has to offer: the bite into a plump apricot, the sound of trickling water, the warmth of the Italian sun, and an alarmingly welcomed first touch on a shoulder all convey the feelings of sensuality that first love can awaken us to in life.

These are the things that director Luca Guadagnino evokes so vividly in creating an endless summer with an amazing visual language (much as he did in his previous film, 2015's *A Bigger Splash*). In a technical sense, Guadagnino understands how to transition between these moments to allow the film to breathe effortlessly into the next as scenes are woven together with cross-dissolves and fades rather than harsh cuts. Adding to the film's overall tone is the original music from singersongwriter Sufjan Stevens, whose whispered, confessional lyrics against the quiet staccato of melodic piano keys perfectly capture and heighten the optimism of discovery in the film.

Based on the 2007 novel from André Aciman of the same name, *Call Me By Your Name* was quickly regarded as a modern classic on first love. Although mainly celebrated in the LGBTQ community for its subject matter, it has since been embraced universally for its portrayal of the joy and heartache that comes from first love that transcends gender or sexuality. The film has also been nominated for six Independent Spirit Awards, including Best Feature, Best Actor and Best Supporting Actor--and if that is any indication, there will likely be many awards tied to this film in the months to come.

Call Me By Your Name is rated R for sexual content, nudity and some language. 132 minutes. Now playing at ArcLight Hollywood and The Landmark. •



Check It Out Into the Water by Paula Hawkins

Into the Water is the follow-up to the blockbuster *The Girl on the Train* by author Paula Hawkins. I was pleased to find that it deals with totally different subject matter, but does retain one element from *The Girl on the Train*--the



unreliable narrator. But even with this there is a twist. Instead of a single untrustworthy

source, in this novel we have several! The Drowning Pool has an irresistible pull for photographer Nel Abbott. When she was a child she was fascinated by stories that recounted the deaths of many women that seemed to be drawn to that beautiful but deadly place. From unlucky teenager Libby Seeton, accused witch in 1679, to unhappy and unfaithful wife Lauren Townsend in the 20th Century, Nel is fascinated. But is the lure of the river too much for her? Nel's lifeless body is discovered and the mystery begins.

Jules Abbott, Nel's sister, arrives in Beckford to try and make sense of her estranged sister's death. Jules will also be caring for a niece she has never met. And Jules has some secrets of her own that she must face.

The townspeople all have opinions about Nel and her obsession with the Drowning Pool. Each person narrates a portion of their own viewpoint, which is layered on top of another's story. Bit by bit, the reader/listener realizes that there is much more at play than the investigation of a single mother's death.

The characters each recall traumas, adulterous affairs, lies and misperceptions that all eventually tie together and amp up the tension. Each time you think you've figured it out, another piece of vital information is dropped. A curveball can come from any angle and you must again sift through the clues anew. Should Detective Inspector Townsend be investigating this case? Is local teacher Mark Henderson involved? What about Louise Whittaker? She recently lost her teenage daughter. Are the deaths connected? Nickie Sage, local "psychic," insists that she is receiving messages from the dead that may implicate someone.

I listened to the book on CD version, which has several entertaining actors voicing several characters. In my opinion, when done well, as in this instance, there is an added nuance to plot and motivation in the story.

This tale is much slower than *The Girl on the Train*. There is much more to discover and those layers upon layers are important and telling. Stick with it and you will be rewarded. It is not until the final "flashback" that everything *might* resolve! You will have sympathy for those "troublesome" women.



That new season has already seen tournament play commence for teams like the West High Warriors and the Torrance Tartars, among others. With a long and challenging basketball season now underway, West will undertake the test of attempting to repeat as champion of the Pioneer League while a new and improved Torrance team will look to become the main obstacle standing in the way.

It wasn't long ago that the West High Warriors went on a run for the record books. Just over eight months ago, the Warriors captured a Pioneer League crown and entered the CIF Southern Section Division 4AA playoffs with momentum on their side. The streak of dominance displayed by West thereafter was nothing short of impressive, to say the least. Five straight victories in the playoffs, including one overtime thriller against the San Marino Titans at West High, led the Warriors straight into the CIF championship game. Unfortunately for West, the team ran into a Helix Highlanders opponent that had only lost six games all season long and went on to snatch the title right out of the Warriors' hands with a disappointing 82-65 victory in the title game.

This year, West will be back and looking to avenge its loss in the championship game. Dealing with a defeat of that magnitude could not have been easy for head coach Neal Perlmutter and the rest of his team. A new season, however, brings with it a new outlook and a new opportunity to exert dominance over the Pioneer League once again. The Warriors will attempt to do so with the return of junior guard Alex Mishaw. Mishaw was instrumental in West's success just one year ago as a sophomore while leading the team on offense. He will look to repeat the accomplishments that he achieved just a season ago.

While Mishaw highlights a group of young players returning to the team, Perlmutter and the rest of the Warrior basketball family will be forced to deal with the departure of a variety of key seniors. Among them are forward/center Noah Carroll, forward Ricky Turner and guard Brandon Thomas. All three players did their part to fill the stat sheet for West High last season. Their absence will surely be missed, but returning seniors like Justin Hight, Nick Snyder and Bryan Souice, to name a few, will look to fill in and return the Warriors back to the glory that the team experienced in 2016-17.

The Torrance Tartars will be looking to suppress West High and capture all available glory for themselves. Torrance may have finished in fifth place in the Pioneer League standings just one season ago, but a new season brings a fresh start for head coach Paul Nitake and company. The Tartars were an extremely young team just one season ago, with only four seniors on the opening day roster. That youth and inexperience could be the main reason why Torrance failed to make it to the playoffs, but Nitake will be looking for major contributions from nowexperienced players in order to improve the team's overall record this year.

Among the more experienced players returning to the roster this season include senior captain Shane Sato and forward Jerome Duhon. Those players are just two of 12 seniors on a roster that has suddenly gotten much older from one year to the next. Tartars fans can also expect major contributions from returning players like guards Logan Young and Daniel Omoto and forwards Darius Holmes and Christopher Pitts, just to name a few. A team that finished with an overall record of 10-18 just one season ago and lost to all of their inner-city rivals including West, North and South High is dead-set on making a much bigger impact on the Pioneer League this year and possibly even taking home its second Pioneer League championship in the last three years of play.

The winter months bring along the perfect atmosphere for indoor sports--and both the West High Warriors and the Torrance Tartars certainly know how to get a gymnasium rocking. A season that is just beginning to get underway remains full of opportunity for teams that were either impressive and made deep runs into the playoffs one season ago or teams that fell upon hard times and didn't experience the best of luck. Last year, the Warriors and the Tartars represented both sides of that spectrum. Lakers, Rookie Ball Experiencing Early Season Highs and Lows

Oftentimes, an NBA fan base can be overly excited when a player is taken high in the draft. Expectations become understandably high as a new hope is enlivened for an organization. Between drafting Julius Randle, D'Angelo Russell, Brandon Ingram, and even now, Lonzo Ball, Los Angeles Laker fans know all about that feeling. A complete rebuild certainly takes time in a post-Kobe Bryant era. Lakers fans have also learned that the hard way. There is no doubting that L.A. is surely inexperienced up to this point in the regular season and their unpredictable play does its own part in portraying that. Not every prospect that puts on the purple and gold is going to be the next Kobe--not even Lonzo. Despite various inconsistencies to start the year, however, an extremely young Lakers team may just be on the right track towards success.

The new star of Los Angeles, at least as far as the Lakers are concerned, is Lonzo Ball. Ball has been the starting point guard of the Lakers ever since the first day of the regular season. Despite Ball's inconsistent play, head coach Luke Walton and the rest of the coaching staff have handled the situation perfectly by keeping the point guard in the starting lineup, despite his off days and subpar shooting from the field. "The benefit is he gets the game experience," Walton explained of the sometimes shaky play of Lonzo. "Whether it's close games, it's blowouts, it's playing against top elite point guards that do different things. He gets all that in-game experience on the go and gets to learn from it all."

Grading Ball on approximately 20 games of NBA play after he spent just one season in college at the age of 20 years old certainly sounds like an unfair thing to do. When you play in Los Angeles and you're the number two overall pick in the draft, though, it sort of comes with the territory. Despite what critics may say of Lonzo, he is certainly young and inexperienced and at times looks overwhelmed on the grand stage of the NBA while taking on superstar veterans like John Wall, Russell Westbrook and more. Even Kobe had a horrible first year in the NBA, though, so this isn't necessarily the time to pull out the report card on the first-year guard.

Despite the inexperience and inconsistencies, however, Ball and the rest of the Lakers team have shown flashes of brilliance--which is certainly something that you want to see from a group of young players. As unlikely as it may seem, most of that brilliance has come on the defensive side of the ball. After ranking dead last in defensive efficiency in each of the last two seasons, the Lakers--behind Ball, Ingram and surprising rookie sensation Kyle Kuzma--were ranking in the league's top five in defensive efficiency as of last weekend. While it is always glaringly obvious when Lonzo struggles on the offensive side of the court, Walton enjoys giving the rookie credit for the team's newly invigorated defensive efficiency. "He's got great anticipation and great hands as a player already, so he's able to get a lot of loose balls for us," Walton explained. "Or he comes down and strips offensive rebounds that guys don't really see him hanging around, which gets us extra possessions obviously."

Those extra possessions have turned into victories for the Lakers too. Less than two weeks ago, Ball recorded his second tripledouble of the season to join Magic Johnson as the only other rookie in Lakers history with multiple triple-doubles in their rookie seasons. Ball recorded 11 points, 16 rebounds and 11 assists in a 127-109 victory over the Denver Nuggets, showing that when he's on his game, Los Angeles can put points up on the scoreboard. "You should always play better in front of your fans," Ball said after that game. "I'm just trying to put on a good show for them and win at the same time." The Lakers were 5-5 at Staples Center dating back to last weekend.

So far in the young season, as Lonzo Ball goes, so do the Lakers. That's not to say that Randle, Ingram and Kuzma, among other Lakers, have not come through with monster games at various times during the year. Ball, however, is the engine that runs the Lakers offense as the point guard. For all of his good also certainly comes the bad. Lonzo's shooting percentage -which was hovering around 31 percent prior to the game against the Clippers this past Monday, ranked worst among rookies who have averaged at least 10 minutes per game. His three-point percentage--at 25 percent--also ranked last among rookies who have attempted more than one three-pointer per game. That poor shooting, from a player who constantly has the ball in his hands, has done its part to not only lead to deficits in games, but also losses this season.

Just like Lonzo, the 2017-18 Lakers team has been full of good play and bad play so far this season. That being said, what more can you expect from a team that is full of youth and inexperience? The takeaway from the first quarter of this regular season is that the Lakers are good enough to at least keep their heads above the water against elite talent, which should certainly garner attention from some big-name free agents come the trade deadline and the offseason. Once a legitimate, big-name superstar is added to this core of young talent, the sky will once again be the limit for the Lakers and all of their fans. – *Aserrao6@yahoo.com* •

The El Camino men's and women's cross country teams competed Saturday, November 18 in the CCCAA State Championships held at Woodward Park in Fresno. The morning conditions were ideal, as was the course--which was in the best shape we have seen in years. The championship races were comprised of the top 14 teams from Southern California and the top seven from the north making the field of 21 teams along with a certain number of qualifying individuals.

The El Camino women went into the championship meet ranked 11th in Southern California with three to four teams from the north "ranked" ahead. Our typical goal is to put ourselves in the best position to "hold" our SoCal place in the face of additional teams from the north, but understanding being close to that would still be a successful run. The women's team rose to the occasion and did just that by placing 11th overall and eighth team in Southern California while defeating conference rival Cerritos for the first time this season in the process. Although our top women got stuck near the rear of the field at the start, they steadily worked their way through the field over the 5,000m course. Freshman Deana Takoaka (South Torrance) was first for ECC in 28th place at 19:28 and followed closely by teammates Savannah Sehenuk (Saugus) in 49th place at 19:52; Brianna Harmon (El Segundo) in 70th at 20:24; Sarah Simpson (Torrance) in 88th at 20:38; and Princess Butler (North Torrance) in 156th at 23:58.

The El Camino men went into the championship meet ranked sixth in Southern California with two to three teams from Northern California "ranked" ahead, putting us somewhere in the eighth to ninth place range. Like the See Cross Country, page 6


Nine-Layer Dip **Grilled** Cheese

Know Thrombosis: Tips To Prevent Deadly Blood Clots

(BPT) - When you think of potentially deadly health issues, do you think of a blood clot? According to a recent U.S. survey, only 7 percent of people say they are concerned about blood clots, known by the medical term thrombosis. However, what they might not know is one in four people worldwide die from conditions caused by thrombosis, making it a leading cause of global death and disability.

So, what is thrombosis?

- Thrombosis is the formation of potentially deadly blood clots in the artery (arterial thrombosis) or vein (venous thrombosis).
- When a blood clot forms in the deep veins of the leg, it is known as deep vein thrombosis (DVT).
- If a blood clot travels in the circulation and lodges in the lungs, it is known as a pulmonary embolism (PE).
- Together, DVT and PE are known as venous thromboembolism (VTE), a dangerous and potentially deadly medical condition. DVT + PE = VTE.

"Thrombosis is a significant public health issue about which many people are unfortunately unaware," says Dr. Gary Raskob, Ph.D., dean of the College of Public Health at the University of Oklahoma Health Sciences

submit a waiver and have health insurance coverage," the association said when the bill was signed on October 30.

It was aimed at stopping employers from handing out phony job titles or small fractions of a business to avoid coverage requirements under the work comp system. surgery, cancer, prolonged immobility, family history, estrogen-containing medications and pregnancy or recent birth. Given that up to 60 percent of VTE cases occur during or after hospitalization, it's important to ask your doctor for a risk assessment anytime you are admitted to the hospital.

"Knowing the facts about thrombosis can save your life," says Mike Albanese, a comedian living with AFib, a common type of irregular heartbeat, or arrhythmia, which can lead to the formation of a deadly blood clot. "As a comedian, I try to use my shows as a platform to educate others about thrombosis, which can be preventable when you know what to look for."

VTE-related events cause more deaths each year in the U.S. and Europe than breast cancer, AIDS and motor vehicle crashes combined. That's why the International Society on Thrombosis and Haemostasis (ISTH) created a global movement called World Thrombosis Day on Oct. 13 to increase awareness of this often-overlooked condition.

When it comes to thrombosis, knowing the signs, symptoms and risk factors can help you keep life flowing.

The 15 percent rule wound up costing medical corporations with 10 owners an additional \$11,000 to \$18,000 per year, the CMA estimated.

Bradford, who is chairman of the state Senate Labor and Industrial Relations Committee, said that he supports all employers paying their fair share for coverage. However, small businesses are being hurt the most. "This bill balances both goals" of preventing premium fraud and removing a cost burden for smaller businesses, Bradford said on his website. Larger businesses and corporations would benefit under the change in law.

Bradford's bill, which Governor Jerry Brown signed in mid-October, rewrites the California Labor Code to ease workers' comp coverage rules and the definition of who is an employee. Under the law, all employees who aren't exempt must be accounted for in a policy for workplace accidents, illnesses and deaths.

An owner or director submits a written waiver under the penalty of perjury, and insurers don't need to verify the information is true. Bradford says on his website that he believes the bill safeguards against more fraud.

Accident insurance rates for all businesses could fall sooner than mid-year. California Insurance Commissioner Dave Jones has recommended that workers' comp insurers lower their rates by as much as 17 percent. His office calculates that the base rate for workplace coverage should be \$1.94 per \$100 of payroll. "The continued decreases in costs to insurers should be passed along to employers through lower rates," said Jones, urging lawmakers to make it automatic. "The law does not require this currently."

The state's elected commissioner advises the insurance industry on what to charge the employers, but can't force them to follow his recommendation. Insurers and their policyholders are seeing lower costs for medical care, which Jones attributes to changes in the law going back to 2012. As a result, claims are being settled more quickly, he reported in late October.

Investigators with the Department of Insurance have cracked down on employers who hide their actual number of employees, while the Division of Workers' Compensation has begun to suspend doctors who are convicted of billing fraud or other crimes. Doctors kicked out of the work comp system cannot treat injured workers or continue to bill their employers for ongoing care.

Fraud in California costs the workers' compensation system between \$1 billion to \$3 billion per year, according to the Department of Insurance.

How to Protect Your Family Against Carbon Monoxide Poisoning

(BPT) - Few areas of the country are immune to natural disasters or severe weather. Whether you live in a hurricane zone or face icy winters, it is important to prepare your home and family to weather the storm and know the potential health and safety risks that may arise in emergency situations.

Beyond inconvenience, widespread and long-term power outages resulting from storms raise a much more serious concern: carbon monoxide (CO) poisoning. While the poisonous gas can come from any fossil fuel-burning appliance or vehicle, the risk posed by generators is of particular concern because of this year's devastating storm season.

"Simple preparation, along with an understanding of the risks of CO, are key factors for protecting your home and loved ones both during storm season and throughout the year," said Tarsila Wey, director of marketing for First Alert. "The risk of CO can occur anytime - not just during emergencies - which is why installing and regularly testing CO alarms are an integral part of any home safety plan."

Often dubbed "the silent killer," the gas is colorless and odorless, making it impossible to detect without a CO alarm. According to the Journal of the American Medical Association, CO poisoning is the No. 1 cause of accidental poisoning in the United States and is responsible for an



average of 450 deaths each year.

CO poisoning is notoriously difficult to diagnose - often until it's too late. Symptoms mimic those of many other illnesses, and include nausea, headaches, dizziness, weakness, chest pain and vomiting. In more severe poisoning cases, people may experience disorientation or unconsciousness, or suffer long-term neurological disabilities, cardio-respiratory failure or death.

Sources of CO may include, but are not

limited to, generators, heaters, fireplaces, furnaces, appliances or cooking sources using coal, wood, petroleum products or other fuels emitting CO as a by-product of combustion. Attached garages with doors, ductwork or ventilation shafts connected to a living space also are sources of CO.

The National Fire Protection Association recommends installing CO alarms on every level of the home, including the basement, and within 15 feet of all sleeping rooms.

These alarms are the first line of defense against CO poisoning.

In case of power outage, never use a generator indoors. Portable electricity generators must be used outside only and should never be used in a garage or in any confined area that can allow CO to collect. When running a generator, be sure to remain 15 to 20 feet away from the outside perimeter of the home and be careful to follow operating instructions closely.

Additional areas to consider include the kitchen stove, a frequent source of CO poisoning in the home. Ensure the kitchen vent or exhaust fan is running to limit exposure. For any fuel-burning appliances in the home, make sure to have a professional inspect them regularly to detect any CO leaks. This includes items such as the furnace, oven, fireplace, dryer and water heater.

If you have an attached garage, it is extremely important to never leave your car running inside. Even if the garage door is open, CO emissions can leak inside the home.

CO alarms should be battery-powered or hardwired with battery backup. To help ensure your family is protected, First Alert offers a variety of alarms to meet all needs, including a table-top alarm with a 10-year sealed battery and digital display to see detected CO levels in parts per million. •
