## **Friends of Library Donate to Summer Reading Program, Youth Services**

Just before the year ends, the Mayor and Torrance City Council members on Tuesday approved and appropriated one more donation from the Friends of the Torrance Library. The monies support the Summer Reading Program (\$25,740) as well as Youth Services activities (\$40,434).

The Friends' donation subsidizes a majority of the incentive prizes provided to participants in the Summer Reading Program, including a paperback book for those who reach their reading goals. Through the program, the Library continues to engage kids of all ages in reading activities in order to prevent the "summer slide," which leads to schoolkids losing reading skills during the mid-year break. "This very popular seven-week program includes programs at all six libraries, incentives for tracking reading progress, and the change to engage with the librarians over books, reading and learning activities," states the staff report signed by City Librarian Hilary Theyer. "The 2016 program was the Library's most successful in the last decade, with significant increases in registrations and the percentages of youth who completed the program." The Library reports that more than 750 kids registered for the program this year, with completions also increasing by 15 percent. In addition to the reading program, the donations made by the Friends will help fund activities such as performers, craft supplies, story and crafts programs, music shows, three youth book discussion groups, teen programs, and supplies for the early literacy storytimes that continue to grow. All of these events take place daily,

on different schedules, and encourage the city's youth to regularly use the library branches. The Friends also fund a public movie license for all six of the branches.

"From thematic t-shirts for staff and all teen volunteers for these programs, to decorations and promotional banners, the Friends of the Torrance Library continue to be the major sponsor of this vital library service," states the staff report.

The Friends of the Library have been a nonprofit group since 1967 and are made up of all volunteers. The Friends raise money through book sales--several of which are organized throughout the year--as well as through daily sales inside the facility (near the checkout counter at the Katy Geissert location). Everything sold by the Friends has been donated to the group. Donations to the Friends can be made at the Katy Geissert Library, which has a drop box near the front door, or at any of the other branches. In addition, the Friends will drive out to collect a donation if it is too big for the donor to bring personally.

The Guilt-Free Secret About Gift Cards

I was thinking about gift cards for everybody on my list this year anyway because December 25 is four days away and I haven't started my Christmas shopping. But an email about a UCLA research project sealed the deal. There's no reason to feel embarrassed about grabbing a handful of gift cards off the cash register rack because you're short on time, according to Professor Cassie Mogilner Holmes. Those cards have an unexpected and beneficial effect on relationships.

Holmes, who's considered an authority on consumer happiness, reports that a palm-sized gift card provides an experience that is more deeply felt than the traditional gifts that come wrapped with a shiny bow on top. "What we found was that the recipient feels more connected to you as the gift-giver after receiving an experiential gift rather than a material one," she said in a guilt-free UCLA press release.

The announcement was perfectly timed as South Bay residents hit the stores for the final countdown to Christmas. The chances of finding the right size, color or style at South Bay stores get slimmer over the next 72 hours. Locally-owned businesses and boutiques offer a variety not found at larger national retailers, and the mom and pops are closer to home than **See Gift Cards, page 4**

## **Up and Adam** Losses Plague Torrance Before Christmas Break

The Torrance Tartars have begun their quest to repeat as Pioneer League champions this year. In a season that is already 10 games into the making, the Tartars and head coach Paul Nitake have experienced mixed results. A 4-6 record may not be exactly where the team would ideally like to be heading into this year's Christmas break, but a win against the Mira Costa Mustangs last Tuesday night could have certainly done its part to dull that pain. Unfortunately for Torrance, the Mustangs came out firing in the first half of play and jumped out to an early lead. The Bay League team was able to coast to a 64-40 victory from there, putting a sour taste on the Tartars' tongue before the team returns to action at the end of the month.

A game that was full of ups and downs for the Tartars saw the team keep things close as early as the first quarter of play. A back-andforth game in the first half had the Tartars take a one-point lead with just under five minutes remaining in the second quarter. Logan Young was the star of the night for Torrance, on his birthday, nonetheless. Despite Young's aggressive play in the first half, the Tartars' defensive effort was held in question. In the final minutes of the first half, Mira Costa was able to rattle off a 9-0 run to take an eight-point advantage into the break.

"Our defense gave up a lot of put-backs early on," explained Nitake of his young team. "We played too much one on one--we should have moved the ball better." Getting a young team on the same page early in a season is something that isn't necessarily easy to do. After all, the Tartars only have four seniors this season after graduating 10 from last year's team. "It's a learning experience for the underclassmen," Nitake continued. "Everyone is trying to find their way." The output from Young, a junior, was certainly a positive sign for Nitake and the Tartars. His 11 points on the night were enough to lead the team, but not enough to save Torrance in the second half of play. The Tartars were dominated inside on the night, most specifically by opposing big man Cameron Steen. Steen scored 14 points in the second half alone to go with nine rebounds.

Despite the loss, the Tartars remain in the mix for in the Pioneer League before league play has even begun. After a short two-week break, Torrance will return to action in the Rancho Mirage Holiday Invitational and look to get things back on track. A date with West High will soon follow when league play starts in the first week of January.

With a swarming defense and key offensive pieces that get the job done, North has made a name for itself in this young season. ## **TerriAnn in Torrance** Christmas and Hanukkah in Torrance

Story and Photos by TerriAnn Ferren Christmas and the first night of Hanukkah fall on the same day this year. Hanukkah starts on the 25th of Kislev on the Hebrew calendar and lasts for eight days. So, Christmas Eve will coincide with the lighting of the first candle of Hanukkah.

Christmas celebrates the birth of Jesus, and Hanukkah celebrates two miracles: the miracle of the defeat of the Greek Maccabees by the Jewish people in Israel in the 2nd Century, and the miracle of having only one day's oil to light the Menorah that miraculously burned for seven days and nights. brought the entire family together. "When Hanukkah came – I didn't get a present every night," Hope said. "I would get a cookie one night, a candy another, and Grandma did a lot of handy work and handmade things. A big thing would be if I got paper dolls. This wasn't like Barbie dolls. These were flat little paper dolls with clothes that had little tabs. It was a big thing to get something like that.

Hope married Michael Witkowski in the early '60s and moved into Torrance. She worked hard passing down the Hanukkah tradition to her children, Debra and Daniel. The only thing was, as Hope told me, "My

### Jesus, Mary and Joseph.

How are people in Torrance celebrating? I decided to find out. Christmas and Hanukkah are only days away and malls and stores are busy with eager shoppers searching for all sorts of gifts. I had a chance to chat with resident and former Torrance Councilwoman Hope Witkowski. She told me that she is a first-generation American. Her mom, dad and grandma fled the Nazis and concentration camps (where some relatives were killed) and arrived at Ellis Island with little more than one suitcase. The Orthodox Jewish immigrants settled in the Bronx in New York. For better weather and work, the family made their way to California and settled in City Terrace. Hope told me, "I was born in 1940 in a one-bedroom apartment--and the war is going on and we were very, very poor, although I never knew it as a child." Because the family was very Orthodox, Hope grew up bilingual, speaking both English and Yiddish. Every Friday, candles were lit and prayers were said, and Jewish holidays

kids [Daniel and Debra] got a present every night. But when the kids went to school at Torrance Unified, Christmas was the big thing and we were the only ones [Jews] on our track. My kids would come to me and say, 'We want a Christmas tree.' I would say, 'No, honey, we are Jewish.' So there was difficulty as a young mother to keep the spirit alive."

Hope continued, "In my day, if I got jacks and a ball it was wonderful, but if I got the paper dolls with the little paper clothes, that was wonderful too 'cuz it was showing the love. I don't know when presents came into this whole thing, but I am sure it was when the Jews immigrated to the United States. Like having Christ in Christmas with Jesus and the manger and all the beautiful things there, which I love seeing. I would think the Orthodox Jews have the same feeling minus presents."

After speaking with Hope, I asked another Torrance resident, Donna Gervais, how she celebrates Christmas with her husband, Bob, and she said, "We will go to church at the children's mass and celebrate with a meal here at home. Christmas we plan on doing turkey--we always do--but when I was little, we had prime rib at my Irish grandmother's house. I remember we always had [for the Italian side, from my father] meatball soup and many other different courses. We did turkey dinners and if we went to my Italian grandmother's, it was a feast. This year, we will do untraditional stuff." Growing up in the '60s with an Italian father and an Irish mother provided Donna with a delightful like Christmas to me than this particular dish (and I will share the recipe upon request).

Adrian Guardado told me his family makes tamales every Christmas. The whole family participates in making a variety of yummy tamales filled with different fillings such as red chili, cheese, chicken, green chili, raisins and sugar. I asked him if they made them the week before Christmas and he said no--they do everything on Christmas. His little nieces and nephews, as he did when he was small, open one gift on Christmas Eve and the rest of their presents on Christmas morning. He told me it is always crazy, but fun.

array of traditions from both cultures. I asked her if she cooks the Old Italian or Irish dishes and she said no. When she was little, she told me the adults took charge of the kitchen and her father was a wonderful cook, but somehow she didn't get that gene. Now, she mixes the two cultures and has whatever the family prefers. Son Michael Gervais and family will be out of town this year celebrating, but daughter Michelle and her family will be visiting from Texas for Christmas. Donna told me, "There is nothing like celebrating the birth of Jesus with family. After all, 'Jesus is the reason for the Season.'"

My house, like the Gervais' home, is decorated with a Christmas tree, a manger and little twinkle lights. Christmas is a day we celebrate the birth of Jesus and usually attend Christmas Eve Mass. Although I haven't yet decided upon a main dish for Christmas dinner, I definitely will make a pot of Aunt May's red cabbage. Nothing smells

Because Christmas and Hanukkah fall on the same day this year, several interfaith couples I spoke with have decided they will celebrate both holidays together. That means a manger with Mary, Joseph and baby Jesus, a Christmas tree, a dreidel (four-sided spinning top) and the lighting of the menorah together. My neighbor Carolyn Weyant grew up with a Jewish mom and a Catholic dad. "My dad, who was supposed to be Catholic, was such a good sport--he knew more about the Jewish religion than anyone and joined right in," said Carolyn. "We had the eight days of presents with Hanukkah, plus Christmas presents. We made out like bandits as kids! So it's quite different now."

In our town, we seek ways in which we are unified--especially this year with Christmas and Hanukkah falling on the same day. Let us see the beauty in our different faiths, traditions and community as we light up Torrance! Merry Christmas and Happy Hanukkah, everyone! •

Even giant e-retailers Amazon and Walmart who carry a wide selection of clothing, toys and electronics aren't miracle workers--though they promise to ship and deliver gift purchases up to Christmas Day. While it's the thought that counts, Holmes says that consumers report more powerful feelings when a gift is an activity or an experience rather than a store-bought item. "And that sort of intensity of emotion translates into feeling more connected and a stronger relationship," she said, after observing similar results within families and between friends. To study the effectiveness of gifts, Holmes and her team measured how closely a group of dads felt to their children before and after Father's Day. The researchers looked at what gifts the children gave, and concluded that fathers who received "experiential" gifts also enjoyed a boost in their relationship with their kids. Parents and grandparents can do better knowing that gift cards are what pre-teens, teens and young adults say they want the most nowadays. Cards generally come in \$10, \$25, \$50 and \$100 values, but most cards are loaded with between \$20 and \$50, according to the people at giftcardgranny.com.

Retail stores and restaurants top the list of most popular gift cards, followed by coffeehouses and the movies, according to giftcardgranny.com. Prepaid cards that bear the Visa, MasterCard and American Express logos make the top five, shows research done by the online reseller of gift cards.

My own circle of friends confirmed what the UCLA professor and a gift-reseller website are saying about this gift-giving shift. Annual sales of gift cards will reach \$1.6 billion sometime next year, according to giftcardgranny.com. I asked my Facebook friends--all with South Bay connections--how they feel about gift cards and who gets one versus a present to go under the tree.

Cindy Ceravalo Stevens admits to feeling like she's "phoning it in" when she gives gift cards instead of a fancily-wrapped present. They might not see it that way since she's sending them to the spa, Starbucks or their favorite dining spot. Though she does add, "I do appreciate receiving a gift card." After-Christmas sales are a reason why my friend Sue Kemp Schultz says she gives them. She adds, "I really prefer gift cards, because they are easier and cheaper to mail. There are way less returns too. Plus, if given on Christmas Day, the recipient can take advantage of 'after-Christmas' sales. And if the recipient wants to re-gift, who am I to judge?"

Another friend, Stella Cordova, says she never likes handing over a gift card to anybody, though they are a win-win especially for kids and for the businesses in town. To dress up cards, she'll wrap them in a small or large gift box, or one that's odd-shaped. "So they immediately know they're getting a gift card, plus we get the look of gifts under the Christmas tree, which is always nice," she told me.

Gift cards have been growing in popularity for almost a decade, and no longer is there the embarrassment of showing up empty-handed to a Christmas party or a family get-together. The path to happiness, which is what Professor Holmes explores in her consumer research, When a person's attention is drawn subconsciously to time, they are more inclined to engage with other people, Holmes discovered. "And that will make you happier than if you were thinking about money," she said.

Luckily for parents and grandparents, today's gift cards have value beyond the \$25, \$50 or \$100 spending limits. They offer experience and freedom for kids and young adults. Spending data also shows that people over 65 plunked down more money on gift cards last year than other age groups. On average, they spent nearly \$190 on them in 2015.

The slow, but steady march to the gift card kiosk makes the retailers happy too because most recipients overspend to get what they really want, according to giftcardgranny.com. The website says it sells traditional plastic cards, online gift cards and e-codes to more than 1,000 retailers and restaurants.


### West High





### **Council Approves Fund** Transfer for MEOC Vehicle

A recommendation by Chief of Police Mark Matsuda to transfer \$55,094.06 from the Installation of Audio Visual Equipment in three meeting rooms to support the Mobile Emergency Operations Center (MEOC) vehicle with city infrastructure received approval from the Mayor and Council. With the Police Department's ongoing efforts to improve the MEOC vehicle, there have been additional infrastructure needs identified to better support the vehicle. The recent discovery is that of a new Wireless Local Area Network (WLAN) antenna to be installed on City Hall's tower,

with an estimated cost of \$36,000. The infrastructural upgrades are listed as needed in order to support a secure wireless connection from the MEOC to the City and Police Department's networks.

"If the MEOC is deployed within range of the City Hall tower [line of sight], the MEOC can securely connect to the network with high speeds and reliability via the WLAN," states the staff report signed by Chief Matsuda. "We would not have to rely on cellular connection...

the MEOC already has a WLAN antenna. The antenna on the City Hall tower is needed to bridge the connection."

The Council approved an agenda item on May 17, 2016 with \$125,000 in asset forfeiture funds assigned to pay for the installation of audiovisual equipment in three of the Police Department's reading rooms. All three rooms' upgrades were completed under budget, by \$55,094.06, and will now be used to pay for the MEOC project. •
